

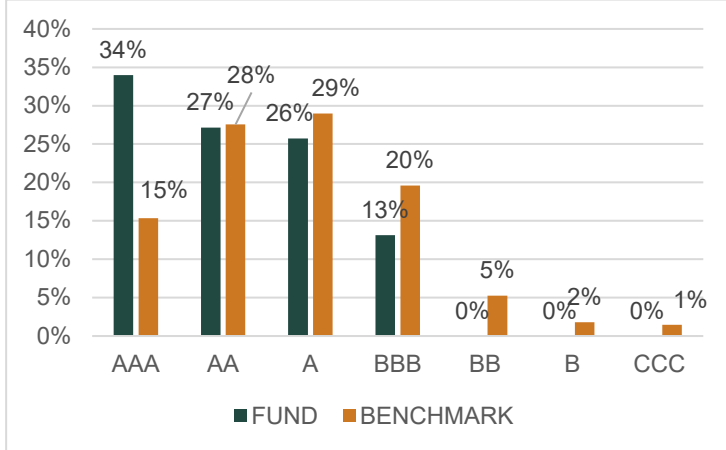

**Sustainability**

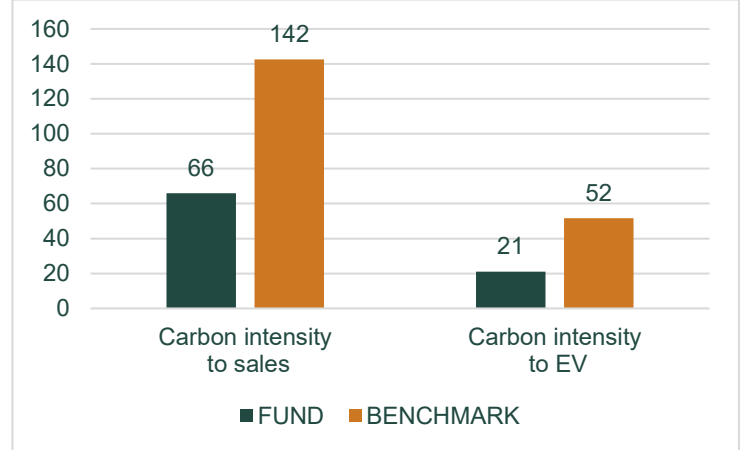
